7.1 Report - Finance 2022-01 2nd Draft 2022 Budget Presentation

Kimberley Pope, Director of Finance/Treasurer reviewed the 2nd Draft of the 2022 Operating and Capital Budget and outlined the options for consideration before Council to approve a 3.6% Municipal Residential Tax Rate increase or provide staff direction on the further budget reductions of \$111,708 to maintain a 2.5% Municipal Residential Tax Rate.

Wayne Hancock, Director of Public Works presented Report - Public Works 2022-01 New Parks and Public Works Millbrook Depot T-PW-21-05 to Council for consideration in the 2022 Budget.
