## **About This Project - Why I'm Here**

- Founder of Second Nature Studio, a grassroots circular economy initiative
- Operating under Clean Up Peterborough (est. Apr. 2024)
- Evolved from community cleanups into a hands-on model for education, outreach, and plastic repurposing
- Second Nature Studio was selected for REIF grant funding to launch a pilot that tests local plastic reuse — with collaboration and community at its core





## The Challenge - What's Not Getting Recycled

- Many smaller #2 (HDPE) and #5 (PP) plastics are missed, misidentified or rejected in standard recycling systems
- Their size, shape and material properties often prevent proper sorting
- As a result usable plastics are regularly send to landfill
   with no local system in place to capture and reuse them





# Second Nature Studio: A Circular Micro-Recycling Hub

- Launching a pilot-scale community plastics facility
- Focused on diverting #2 and #5 plastics for shredding and reuse
- Will recover and repurpose common plastics that are too small, complex, or inconsistent to be captured through traditional recycling
- Exploring a potential space partnership with the City of Peterborough









# The Pill Bottle Project – Launching July 1st Goal to Divert Prescription Pill Bottles from Landfill



- Estimated 600 million bottles used each year in Canada
- Because of small size and type only about 10% are recycled
- Almost 2 million end up in landfills in Peterborough County
- In discussion with local Pharmacies and Vet Clinics goal to have locations across the County begin collecting them
- Hoping to expand collections to include long-term care facilities, retirement homes and other locations where medication is distributed in bottles
- Once processed, bottles can be remade into durable, reusable products — tailored for practical use in local businesses, education, or outreach

### **Other Initial Streams**

- Downtown café partnerships small plastic packaging & containers
- Black takeout containers common, banned from recycling
- Nursery pots seasonal overstock from growers
- Also collaborate with restaurants, salons and laundromats to collect both small and colourful plastics
- Grassroots collection model: easy, visible, low-barrier







## **Long-Term Vision**

- Expand to include hard-to-recycle collections (e.g., TerraCycle)
- Community education & outreach (schools, pop-ups, makerspaces)
- Mobile collection events across rural areas
- Support small business + public involvement in circular economy

























## **Opportunities to Collaborate**

- Pilot plastic collection bin or community drop-off in Cavan Monaghan
- Co-host an educational event, workshop, or school program
- Share local insights on rural plastic diversion challenges
- Explore space, support, or funding partnerships to scale outreach
- Champion a made-in-Cavan-Monaghan circular model of plastic reuse





## **Why Local Matters**

"The plastic's already here. The real question is: how do we use it for good - rather than ship it off and hope it gets recycled?"

"Keeping our plastic local means transparency, trust, and lowering emissions - plus powerful education moments for youth, families, and the broader public."
